Community Healing Centers' programs and staff are dedicated to providing individuals with connections and resources to access the help they need; whether it's substance use disorder treatment, therapeutic support for a child, adult mental health services, or prevention for at-risk youth.

CHILDREN'S SERVICES

Early Intervention Program

This program is for parents and caregivers with infants and young children ages 0-6. We provide intensive homebased therapy and case management services to families in Kalamazoo County.

Treatment and Outreach

Children's Treatment and Outreach provides effective counseling and programming, so children and their families can

Children's Advocacy Center

The Children's Advocacy Center of Kalamazoo is a caring, child-focused, safe place for children who have been sexually or severely physically abused. Our specially trained forensic interviewer works with an investigative team to further the prosecution of child abuse cases, while our therapeutic staff offer individual and group counseling to the child and non-offending family members. clients received 1,403 hours

PREVENTION PROGRAMS

S.T.R.E.E.T. After School & Summer Program

S.T.R.E.E.T. works to reduce "risk factors" in strategically targeted neighborhoods, such as the northside of Kalamazoo. By using a trauma focused approach, we provide services for boys ages 10-17 who are academically, socially, and emotionally delayed, or experience behavioral/mental health



problems as a reflection of vulnerabilities in the communities in which they live. The program is structured to eliminate racial barriers and stigmas that have a negative influence, as well as decrease underage drinking and drug use among adolescents.

Niñas del Corazón (Girls of the Heart)

Niñas del Corazón serves as a breezeway or haven for adolescent Latina girls ages 8 - 15 during critical after school hours. It is the first of its kind to be

implemented in the region and implements an innovative approach to provide immediate support to address the needs and concerns of the community, while focusing on Latina girls and their families. It addresses low academic performance, underage drinking and drug use, acculturation trauma



awareness, and social emotional skills development.

ADULT OUTPATIENT MENTAL HEALTH AND RECOVERY SERVICES

Individuals interested in mental health counseling are assessed to identify needs, and treatment plans are developed to create a personalized therapeutic program. Our goal is to assist in managing symptoms while dealing with everyday stressors through basic life-skills training, peer support, relapse prevention planning, and individual, couple, and family sessions.
